  - Administrative
    - No report
  - Finance (John Andrejack)
    - MOE testing, just wrapping up, working with PSC to do new testing model for MDE (just beginning to develop that model, will work with business officers to further develop, will be as simple as possible, will build from there), aggregate testing, will be an "add on" in the CIMS workbook somehow, will be available after people submit flow through applications, will be developed by mid-June and will be out toward the beginning of July, there used to be an assurance statement that districts were budgeting for MOE
    - Electronic 4096, piloting going on this fall
  - Program Accountability
    - No report
- 2. Current Legislation MI Update Karoub & LAC
  - Seclusion & Restraint
    - A lot of movement in the last couple of weeks, meeting was held with other school
      associations and the LG's office, LG's office provided new drafts, taken all suggestions into
      account, been a really good process
    - May be up for a hearing this Thursday, if not this week, next week
    - Campaigns could impact this legislation
    - The MAASE board will undergo a process to consider moving from neutral to support in the next couple of days
  - K-12 budget
    - 51a: funding for sped services for students at virtual academies
    - Foundation allowance increase...more for those that are lower now
    - \$\$\$ for seclusion and restraint training
    - DPS...caucusing on this issue all day today

    - Introduced every session for the last 10 years...related to state regulations cannot be more stringent that federal policy
    - "Clear and convincing evidence" must be shown by the director of the office to demonstrate the need to go beyond the federal rules
  - SB 962
    - Would allow for JCAR to make changes to state regulation proposed by various departments and would have to be approved by the full legislature
