1. Office of Special Education Updates

- Administration

 - Nancy Rotarius: FAQ on 3rd Grade Reading Bills available online and it addresses special education and students with significant needs, it is constantly evolving as more questions come in, will be updated periodically. MDE-earlyliteracy@mde.gov
 - Seclusion and Restraint: maintaining a list of questions and will possibly update FAQ as needed, MAASE is looking to start a CoP to address

Finance

- Scott Kemmer-Slater: Diane Easterling is retiring in December, MOE is still working on the 15-16 compliance testing done in Catamaran, having some issues they are working through, trying to get to 16-17 and hope to get to 17-18 during the normal time frame
- State has a new accounting system, after that is implemented EOSD funds will be made available

2. **Karoub Update** (Emily Laidlaw)

- Karoub reports are available monthly on the MAASE Wiki (under the heading of "Updates")
 - 4166: local/ISD hiring preference, fixing an issue that was created last year
 - 4205: no rules more strict than federal rules, working to protect special ed rules, special ed is the only exemption in the bill
 - Seclusion & Restraint: amendment to law that make School Resource Officers exempt from the bill
 - Supplemental Budget, more changes than usual as a result of the MPSERS argument last spring: CTE changes, At Risk definition, GSRP entry date
 - FY 2019 Budget: EO Funding request will be included
 - Pre Labor Day Start: stalled in the Senate, opposition from the Chamber of Commerce
 - New Accountability System: A-F style, trying to push that through
 - Sub Shortage/Teacher Prep: stalled because the view is that teacher prep needs to be fixed too....will have a hearing about sub shortage in the next
 - Enhancement Millage: will change that enhancement millages will need to go to PSA's too
 - o MMC amendments: lots of bills are out there, flexibility for CTE is a theme

3. BoD & LAC (Eric Hoppstock/Andy Claes/Abby Allen)

 Approved white paper/position paper related to EO Funding ask of the legislature (now posted to the Wiki)

- LAC: looking at dispute resolution and what other states are doing and what does it look like when it is done well, will be working on a position paper
- LAC: working on the possibility of a quarterly update to membership related to legislative updates/LAC work
