## 1. Office of Special Education Updates

Allocations will be a combined EOSD and Transition grant with an increase of $10 \%$. They will be reviewing appropriate allocations for that work in the future. They will not be reducing allocations for ISDs moving forward. The application will come out in a word document.

## 2. Karoub Update (Emily Laidlaw)

- Karoub reports are available monthly on the MAASE Wiki (under the heading of "Updates")
- Budget: Senate reported out before break. They want to get out early June to get on the campaign trail so this will be a short session. Many good things got in that are good for ISDs and SE generally. 5 million got in for Early On. It is another thing to keep this in the final. The other win was getting the distribution changed to the current formula instead of competitive grant. There is also a line item for the Special Education Task force work on Parent learning and mediation. Section 81 of the budget has been flat for ISDs for year and this year it includes a $1 \%$ increase. Section 56 of state school aide act has been included for a long time and deals with mileage equalization. 56 is special education and attempts to provide a formula to give equity to counties, which added 4.5 million this year.
- Policy: Attempt to extend critical shortage and sub laws. They would like to expand it more but that seems to be challenging. There is a teacher prep package being sponsored by the house.

Universities aren't happy with this. They are trying to do this by changing certification requirements and alternative certification.

- Nassar: There is a package of bills around this. There will be a new package coming from the house probably this week. There are some real world policy implications in this that we need to pay attention to. This needs to be done slowly and carefully.


## 3. BoD \& LAC (Eric Hoppstock/Andy Claes/Abby Allen)

- Andy mentioned the opportunity to attend the CASE/CEC legislative action conference in July. This is an opportunity to engage at the federal level. We are offering 2 scholarships. He also mentioned being cognizant of opportunities to engage with our partner organizations such as MASA and MAISA.
- 871-879 are the Senate bills on Nassar.
- If critical shortage goes away we will all be impacted. We need to be diligent in ensuring we don't lose this. We need to make the connection between that and teacher loan forgiveness.
